Since the original publication of this book in 1979, the authors have experienced two matters of interest. Individual purchasers and professors who have adopted the book for their courses have invariably remarked very favorably about the book's scope, its treatment of issues important to them, and its readability. Based on these reactions, the authors feel that the original intent in writing such a book has been achieved.

That in itself is not a revelation; however this realization becomes acutely obvious when one attempts to keep abreast of court decisions that affect in some way what has already been written. The authors decided that five years is long enough before revising the book.
